3 (a) The objects to be pursued by the company on its incorporation are:

1)To carry on the business of manufacture of Agriculture tools, tractor, power weeder and tiller, brush cutter, thresher, Tractor Attachment, Harvesting machine, Agri Robotic machine, Shed net , vertical Farming, agriculture cluster, agriculture garden tools, fish farming technology, agri Boat manufacturing, agriculture transport network, agriculture construction like Dam ,pond, River project, agriculture home construction, agriculture TV channel, agriculture medicine, agriculture institute , agriculture lab , agriculture information technology, Agriculture electric machine manufacturing, technology upgradation, , agriculture society, agriculture bank , agriculture media.

2)To carry on the business of import and export of agriculture products.

3)To Process plant, sugar mill, gour gum plant, cotton and provide Agri Education, Agri

sprayer, winery, jaggery, disleri and maize, vegetables dehydration, Solar plant , Wind mill plant, fish farming, technology collaboration, Agriculture solutions, Agriculture training, Exhibition, Agriculture seed production, West management.

4)To promote Agro industry and agriculture development, , agriculture rural development and agriculture science.

5)To provide agriculture tourism, agriculture home construction, agriculture dairy plant.

6)Manufacturing Agriculture Earthmoving equipment, Forestry Machine, Milking machine, agriculture cargo vehicle.

7)Collaboration for Agriculture floriculture technology, advance software, agriculture spraying equipment, Silk plant , cotton process plant, Oil mill , animal operated machine, Hand tools manufacture, agriculture safety management, agriculture wood process plant , vegetables dehydration plant, Advance fruit preservation plant , vegetables nursery, Fruit Plants nursery, Gardening machine, Grain filter plant, dal mill plant, oil mill plant, stone crashing plant.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To establish agency of, franchise, any subsidiary Company or Companies, and to organise, promote and incorporate such subsidiary company or companies and to enter into any arrangement with such subsidiary company or companies for taking the profits and bearing the losses of business or branch so carried on or guaranteeing its liabilities, or to make any other arrangements which may seem desirable with reference to any business or branch so carried on including

power at any time and either temporarily or permanently to close any such branch or business or subsidiary Company. And to acquire and undertake the whole or any part of the business, property of any person, association of persons, partnerships, proprietary concerns, body corporate or company carrying on any business .

2. To open branches of the company in as well as outside India and to perform the acts that may be necessary or convenient for achievement of main objects of the Company.

3. To carry out Research & Development activities in furtherance of Main Object of the Company.

4. To conduct or participate in exhibitions, trade fairs for promoting the Main Objects of the company.

5. To acquire information as to process of producing, purchase, sell, import, export, treat & deal in products of the Company & to arrange training programs for employees of the Company.

6. To give expert technical assistance, maintenance, after sales services, financial and managerial advice to the individuals, industries and others engaged in similar business and for the purpose of the business to promote, counsel and to protect and promote their interest.

7. To depute any of the representatives, selling agent, wholesalers, distributors, directors, or other employees of the company to any part of India or abroad for the purposes of promoting and conducting more profitably all or any of the business of the company.

8. In connection with such business or businesses, to take

on lease, rent, purchase, hire, contract/provide shops, offices cabins or any immovable property.

9. To enter into agreement / partnership or joint venture or collaboration for the business or its development / expansion with any party, either Indian or foreign, and to pay in cash or n kind or both for consideration of such agreement.

10. To employ required staff or otherwise appoint technical experts, designers, mechanics, engineers whether from India or any other country skilled and unskilled labour for any of the purposes of the company and to remunerate them from time to time, to enter into agreements with them laying down term and conditions of employment, remuneration, commission.

11. To enter into contracts, agreements and arrangements with any other company, firm, or person for carrying out by such other company, firm or person in India or elsewhere on behalf of the company any of the objects for which the company is formed or is entitled to carry on.

12. To borrow or raise monies or loans for the purposes of the Company by promissory notes, bills of exchange hundies and other negotiable or transferable instruments or by mortgage, charge, hypothecation or pledge or by debenture or by debenture stock, perpetual or otherwise charged upon all or any of the Company s property and assets both present and future, movable and immovable including its uncalled capital upon such terms as the Directors may deem expedient and in such other manner or take monies, deposits or otherwise (merely for the purposes of financing of the business of the Company, with or without allowance of interest thereon and to lend money to customers and to guarantee the

performance of contracts by any such persons and to execute all deeds and writing assurance for any aforesaid purposes

13.
